

## MINUTES OF THE FRENCH ARCHDEACONRY SYNOD, MAY 2017

The Archdeaconry Synod of France and Monaco met at the Abbey at St Jacut de la Mer from the evening of 17<sup>th</sup> to the morning of 20 May 2017.

The Opening **Synod Eucharist** was celebrated by the Archdeacon.

### **Session 1: Opening of the Synod**

---

The session was chaired by the Archdeacon, who welcomed members and guests to the third annual Synod in this triennium.

- **The Archdeacon's Address**

The Archdeacon introduced the theme of the Synod, "Walking together in Faith?" Walking together in faith should give us a sense of belonging and a common goal.

- **Safeguarding**

The Archdeacon outlined the precautions on safeguarding that have become necessary in recent years. Training is particularly important and two training days for Stage 2 of the Diocesan programme had already been held. The Diocese would be the focus of an independent inspection in the autumn of 2017.

- **Website**

The new Archdeaconry Website is being launched at this Synod (*anglicanfrance.fr*). It aims to share information within the Archdeaconry and between individual chaplaincies, give news on developments and advertise events. The webmaster is Rosemary Ulyett and the contact address for sending information is [contact@anglicanfrance.fr](mailto:contact@anglicanfrance.fr). This year the individual chaplaincy reports can be found on the website.

- **RSCM**

Representatives of the Royal Society for Church Music are prepared to help chaplaincies with their music.

- **Positions vacant**

A new environmental officer is needed in the Archdeaconry, as well as a person to take over from the Rev'd Gareth Randall in preparing the Prayer Diary.

- **Finance**

The Archdeaconry Treasurer, David Bean, referred people to the financial report in the Synod brochure and then gave a brief summary of the current situation.

### **Sessions 2, 3 and 5: The Diocesan Strategy**

---

The Bishop began his talk with reflections on Brexit. For the Diocese in Europe there could be difficulties in such areas as clergy recruitment

The Diocesan Strategy focuses on the following five major areas:

- Building up the body of Christ and fostering growth;

- Sharing with other churches in the evangelisation of Europe;
- Striving for the creation of a just society and a sustainable environment;
- Working for reconciliation;
- Resourcing through stewardship of our gifts and talents.

Discussion of the Strategy, including examples of good practice etc., have taken place at Diocesan Committees and Councils, Archdeaconry Synods as well as Chaplaincy Councils.

All five areas of the strategy have seen activity and fruitful initiatives, including:

- Appointment of a Diocesan Director of Lay Discipleship;
- The drawing up of a Diocesan Rule of Life;
- Work on migration/refugees;
- Improvements in the safeguarding process;
- Support for Archiepiscopal links with the Patriarchs of Russia, Constantinople, and Serbia.

#### **Session 4 Training for Lay Ministry (*renamed Training for Lay Discipleship*)**

---

Dr Amos explained that she had recently become the honorary Director for Lay Discipleship in this Diocese. Her talk at Synod can now be found on the website.

#### **Thursday evening Eucharist**

---

The Reverend Giles Williams was installed as Area Dean for South Eastern France (including Lyon and Grenoble) at the Eucharist on Thursday evening.

#### **Sessions 6 and 7 Professor Michel Mounir Bondurand Mouawad**

Professor Durand from the University of Paris 3 La Sorbonne gave an interesting and instructive talk on French Islam. His **presentation** is available on the Archdeaconry website.
